When you examine the STCW endorsement on a Coast Guard issued Merchant Mariner Credential (MMC), what do the Roman Numerals and Numbers mean regarding their STCW qualifications?

The following is organized by the STCW Code Chapter, the MMC STCW regulation qualification notation meaning, included are the new regulations from the \*\* STCW Code 2011 "Edition":
